 Consolidated Profit after tax in Quarter III/2024 was 201.48 billion VND and increased by 182.93 billion VND compared with the same period in 2023 (of which consolidated profit after tax in Quarter III/2023 was 18.55 billion VND). The main reason is that in this period, the Company recorded more revenue from industrial park business activities compared to the same period last year.

- Separate profit after tax in Quarter III/2024 was 95.92 billion VND and increased by 85.64 billion VND compared with the same period in 2023 (of which separate profit after tax in Quarter III/2023 was 10.27 billion VND). The main reason is that in this period, the Company recorded more revenue from industrial park business activities compared to the same period last year.
